INITIATION FEE

MONTHLY DUES
\$400

Includes 6 rounds of golf at PCC annually; greens and cart fees applicable
Reciprocal privileges at all McConnell Golf owned properties, excluding golf
Membership Initiation fee due at time of joining
A \$50 food and beverage monthly minimum applies in addition to dues

CLUBHOUSE

INITIATION FEE
\$7,000

Family access to swimming pools, fitness center, dining and social events
Includes 6 rounds of golf at PCC annually, must be accompanied by a Full Golf member; greens and cart fees applicable

MONTHLY DUES
\$300

Reciprocal privileges at all McConnell Golf owned properties, excluding golf and tennis
Membership Initiation fee due at time of joining
A \$50 food and beverage monthly minimum applies in addition to dues
