The line then transitions from cast iron to terracotta. At this transition there is a minor offset with a root intrusion. Theres one more root intrusion about 4 feet after this. After these 2 minor root intrusions, the line continues out to 175 feet long. The entire distance is in good shape. The line is terracotta sewer all the way to the city tap. There are no major or minor breaks/ cracks, all joints are in good shape with no major defects. The last connection to the city sewer again has a root intrusion. The root intrusions should be cut and removed every year as is typical within most homes in the area. Terms

Responsibilities and Representations of Customer

Customer agrees to hold Planet Plumbing & Drain ("Company") harmless for any of the following existing conditions:

- · Leaking or defective piping
- Improper or faulty plumbing
- Damage caused by cleaning chemicals, acids, or lye
- Drain or sewer lines that are settled, broken, deteriorated, or damaged
- Corrosion or blockages due to mineral buildup or hard water
- Damage to pipes and/or fixtures during normal service
- · Any resulting damage to property or personal belongings during the course of the Company's work
- Broken pipes, whether waste & drain or water supply systems
- Plumbing code violations and/or outdated plumbing
- Lead, cast iron, or galvanized pipes
- Fixture damage such as cracks in toilets, tanks, supply lines, sinks, or drain lines
- Hidden pipes in walls or ceilings, or under concrete or dirt, including p-traps and drum traps
- Electrical wires and/or outlets near plumbing lines

Customer understands that access to plumbing may require cutting into walls, ceilings, floors, tile, lawns, sidewalks, or driveways. Restoration of these areas is the sole responsibility of the customer unless otherwise specified in writing.

Customer further acknowledges that plumbing systems may be vulnerable to damage caused by freezing temperatures. The Company is not responsible for damage to any plumbing or property caused by freezing. Customers are responsible for adequately winterizing or protecting their plumbing systems. There are inherent risks in attempting to clear clogged drains or sewers, and the customer assumes all such risks.

Not Responsible for Conditions Outside Scope of Work

Planet Plumbing, nor any of its vendors, can be held accountable for any damage to post-tension cables, structural problems, earth shifting and/or sinking that may arise from this job. We cannot be held liable for any cave-ins or collapses of the earth and soil. We are not responsible for any damage or repair to drywall, brick, stucco, paint, hardwood flooring, or tile surfaces.

We are not responsible for removing or replacing electrical outlets, fixtures, cabinetry, appliances, or furniture.

If incoming water pressure to a building or home is 90 psi or higher, Planet Plumbing cannot offer any warranty on any repairs or alterations to the domestic or irrigation water systems of the structure. All agreements are contingent upon strikes, accidents/delays, epidemics, pandemics, and forces of nature beyond our control.

Landscape and Hardscaping Disruption

We will attempt to preserve all grass; however, we cannot guarantee that it will survive. We are not responsible for any gardening repairs or gardening "put back." If a shrub needs to be removed, we will remove it, but we will not put it back. Prior to any excavation onsite, we will contact 811 to mark all utilities in the area. We are not responsible for any hardscaping.

Responsibilities of Company

The Company will perform all work in a good and workmanlike manner. This does not expand the Company's liability beyond what is stated under the warranty section.

The Company is not responsible for damage to fixtures, pipes, or appurtenances that are rusted, broken, or otherwise compromised. If removal causes damage and repair or replacement is declined by the customer, the Company is not liable for resulting issues such as gas odors, leaks, backups, or water damage.

Insurance and Damages

The Company maintains all legally required insurance, including workers' compensation and liability coverage.

Any property damage allegedly caused by Company personnel must be reported immediately in writing. The customer must allow the Company and its insurer to investigate. If liability is determined, the Company may choose to clean, repair, or replace the damaged item.

Jobs Not Completed

If the customer directs the Company to stop work before completion, the customer agrees to pay for all time and materials expended to that point. Such a direction must be in writing. The Company is not liable for any resulting issues caused by incomplete work.

Payment Terms

CASH: Payment is due upon completion unless otherwise agreed.

ACCOUNT: Authorized account work must be paid within 10 days.

DELINQUENT ACCOUNT: After 30 days, accounts are considered delinquent. The customer agrees to pay all court costs, attorney's fees, and interest at 18% per annum on overdue amounts.

Returned Checks

A returned check incurs a \$15 fee. If not paid within 12 days of notice, the customer may be liable under Colorado law for up to 3x the check's face value (not to exceed \$1,000, with a minimum of \$100), plus legal fees and 18% interest.

Standard Warranties

- New fixture installations: guaranteed for one (1) year from installation
- Drain cleaning: 30-day guarantee, unless otherwise noted
- Main sewer lines with root issues: 90 days against blockages caused by roots
- Residential toilets: 7 days
- Commercial toilets/floor drains: 48 hours

Repeat stoppages will be serviced again during the warranty period at no additional charge up to the amount of the original invoice. Additional labor is charged at the prevailing rate. The warranty period does not reset with re-service. The Company is not liable for any secondary damage due to service delays or backups outside of its control.

Entire Agreement

This document is the complete and exclusive agreement between the parties. No verbal agreements, representations, or outside commitments are binding unless written in this document or the accompanying invoice. This agreement binds the customer and their agents, heirs, representatives, successors, and assigns.
