- Declarant caused to be recorded in the Office of the Register of Deeds for Madison County, North Carolina a Declaration of Covenants, Restrictions, Easements, Reservations, Terms and Conditions Governing Beth Hanan, a Subdivision of Madison County, North Carolina, in Book 695, at Page 530, herein "Declaration".
- 2. Declarant now desires to amend said Declaration.

NOW, THEREFORE, Declarant, pursuant to Article III, Section 3.1 of the Declaration does hereby amend the Declaration as follows:

A portion of Section 7.3 reads as follows:

"No one-story residential structure which has an area of less than One Thousand two hundred (1150 SF) (sic) square feet finished and heated living space on the main level, exclusive of porches, breezeways, steps and garages, shall be erected or placed or permitted to remain on any lot. No one and one-half (1 <sup>1</sup>/<sub>2</sub>) or two-story (2) residential structure which has an area of less than One Thousand Two Hundred (800 SF) (sic) square feet finished, heated living space on the main, exclusive of porches, breezeways, steps and garages, and not less than a total of One Thousand Six Hundred (1400 SF) (sic) shall be erected or placed or permitted to remain on any lot."

Submitted electronically by "Best and Best, PLLC" in compliance with North Carolina statutes governing recordable documents and the terms of the submitter agreement with the Madison County Register of Deeds. Said portion of 7.3 is hereby amended as follows:

No one-story residential structure which has an area of less than One Thousand Fifty (1050 SF) square feet finished and heated living space on the main level, exclusive of porches, breezeways, steps and garages, shall be erected or placed or permitted to remain on any lot. No one and one-half (1 <sup>1</sup>/<sub>2</sub>) or two-story (2) residential structure which first story has an area of less than Eight Hundred (800 SF) square feet finished, heated living space on the main, exclusive of porches, breezeways, steps and garages, and not less than a total of One Thousand Three Hundred (1300 SF) shall be erected or placed or placed or permitted to remain on any lot."

A portion of Section 7.3 reads as follows:

No residence shall be located nearer than twelve (12') feet to any interior lot line.

Said portion of 7.3 is hereby amended as follows:

No residence shall be located nearer than eight (8') feet to any interior lot line.
