Synopsis

Lake trout and brook trout were probably the native sport fish species of Rebecca Lake.

The 1982 lake trout assessment concluded that water chemistry and biological properties were not suitable for supporting a lake trout fishery. It was recommended that lake trout should not be stocked. While it is true that there was no indication of natural recruitment, subsequent temperature-oxygen profiles indicate that there is sufficient habitat to support a put-grow-take population. Also, the low netting success for lake trout in 1982 may have been a result of the limited lake trout stocking in proceeding years. Since the lake was last stocked with lake trout in 1977 with only 67 fish and 1000 in 1965 it is no wonder the netting success was so poor. Accordingly, lake trout stocking resumed on Rebecca Lake in 1994 on a put-grow-take basis. The open season for lake trout was extended to open all year in 1999.

The 2013 winter survey found that fishing effort was moderately low and only one fishing hut was present. Despite the restrictive slot size limit, neighbouring Bella Lake received somewhat higher relative fishing effort reportedly due to real or perceived greater fishing success. Netting done on Bella Lake has found that a significant number of lake trout stocked into Rebecca Lake, emigrate to Bella Lake, potentially interacting with the native lake trout population.
