THIS FIRST AMENDMENT TO MASTER DEED OF THE TIDES HORIZONTAL PROPERTY REGIME (this "First Amendment") is made this 5 in day of February, 2013, by the Tides Horizontal Property Regime Owner's Association, Inc. (the "Association").

### BACKGROUND STATEMENT

Whereas, Carolina Eastport, LLC, a South Carolina limited liability company, previously made, submitted and established the Master Deed of Tides Horizontal Property Regime, dated June 19, 2008 and recorded July 20, 2007, in Book C633, Page 488, of the RMC Office for Charleston County (the "Master Deed"); and

Whereas, pursuant to Article X, Section 10.3 of the Master Deed, the Master Deed may be amended from time to time, after appropriate notice of the subject matter of the proposed amendment is given, and a meeting is called in accordance with the Bylaws of the Association, whereupon there is an affirmative vote of the Owners constituting at least sixty-seven (67%) percent of the total interest in the Regime; and

Whereas, this First Amendment is executed by the Association, following the affirmative vote and consent of Owners holding at least sixty-seven (67%) percent of the total interest in the Regime; and

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, pursuant to the powers reserved under the Master Deed as set forth above, the Association hereby amends the Master Deed as follows:

- **<u>DEFINITIONS.</u>** Any capitalized term used in this First Amendment and not defined herein shall have the definition set forth in the Master Deed.
- ARTICLE IV Amendment. Article IV is hereby amended to include the following Section 4.10.1:
  - Section 4.10.1 Payments to Working Capital Account. In order to provide the Association with adequate working capital funds, the Association shall collect from the purchaser at the time of sale of each Residential Unit an amount equal one fourth (1/4) of the annual regular Assessment for such Unit in effect at the time of the sale. This provision shall not apply to any transfer of ownership without substantial economic consideration (as determined by the Board of Directors), such as transfer of ownership

{00309423.DOC 3} 1 pursuant to a will or intestate proceedings upon the death of the Owner of the Unit. The Association shall maintain the working capital funds in a reserve account to meet unforeseen expenditures or to acquire additional equipment or services for the benefit of the Association. Such payments shall not be considered advance payments of regular Assessments.

4. <u>CONSTRUCTION</u>. Except as set forth in this First Amendment, the Master Deed shall remain in full force and effect, and any ambiguity between this document and the Master Deed must be resolved in favor this First Amendment.

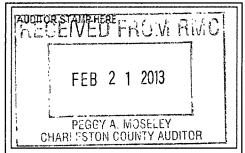


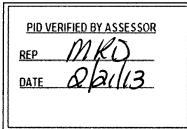

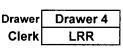
