@2014, garbage disposal leaked. Under sink area was professionally cleaned and wood replaced. Disposal replaced.

2017 - Hail damage caused leak in skylight in kitchen. Was replaced along with roof.

@ 2017 - AC drain line over front door came loose and caused minor leak in front bedroom ceiling. Was repaired by HVAC company and no further incidents.

(Wood Rot) Some around bottom of barn walls.

(Previous treatment for termites or WDI) Professionally treated for carpenter ants along front of house



approx. 2009 and 2023. No signs of further activity.

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is considered to be a moderate risk of flooding.

"Flood pool" means the area adjacent to a reservoir that lies above the normal maximum operating level of the reservoir and that is subject to controlled inundation under the management of the United States Army Corps of Engineers.
