DO: <ul style="list-style-type: none"> Put only water, human waste, and toilet paper down the drains. Have tank pumped out every 3-5 years. Divert all water and gutters away from tank and drain lines. Spread out water usage (washing machine, showers, dishwasher). 	DON'T: <ul style="list-style-type: none"> Pour fats, oils, or grease down any drain or toilet. Put kitchen scraps down the sink. Use the toilet as a trash can; no condoms, tampons, paper towels. Flush "flushable" wipes, they will clog your tank. Use additives or chemicals; they are NOT needed. Save your money for future pump outs. Plant, park, or build on top of your drain lines.
